MINUTES OF A SPECIAL MEETING

On the 28th day of February 2023, the City Council of Taft, Texas, convened in a special meeting at 402 Park Street, Kiva Hut, at 6:31 p.m. with the following members present:

#1. CALL TO ORDER AND QUORUM CHECK

There being a quorum, the meeting was called to order by Mayor Powell.

#2. INVOCATION AND PLEDGE

Councilman Rodriguez led the Invocation and Pledge of Allegiance.

VISITORS

Glenn Searcy commented on employee pay and decaying buildings.

Scott Patton addressed the Council on behalf of the Taft Volunteer Fire Department with his concerns regarding equipment and building maintenance. He also commented on the qualifications of the Interim City Manager, Sid Arismendez.

#3. PRESENTATION BY CARYN BINGHAM, HOMELAND PREPAREDNESS PROJECT

Ms. Bingham, Homeland Preparedness Project, working with San Patricio County Emergency Management with a CERT (Community Emergency Response Team) program and is asking use of the Kiva Hut to provide citizens a training course that prepares them for an emergency disaster or response. Tentative dates are set for March 31, 2023 thru April 2, 2023.

#8. <u>DISCUSS, CONSIDER AND ACT ON BUDGET AMENDMENT TO PROVIDE FOR CITY</u> ASSISTANCE FOR ROOF REPAIRS TO BLACKLAND MUSEUM.

David Smith addressed Council on behalf of the Taft Blackland Musuem asking for funding consideration of \$15,000 for continued repairs to the roof on the building. Mayor Powell responded that the current budget would be reviewed, and would return this item on the March 14th agenda for consideration. No action taken on this item.

#7. <u>DISCUSS, CONSIDER AND ACT ON RELINQUISHING OWNERSHIP OF 12" MAIN LINE WATER INLET TO SAN PATRICIO WATER DISTRICT.</u>

Brian Williams, General Manager, and Jake Krumnow, Operations Manager, from the San Patricio Municipal Water District addressed the Council regarding a 12" main water line located on Hwy 181 from West Portland

Gin to the 500 block of Davis Road that is currently owned and maintained by the District. The City owns a water meter beginning at West Portland Gin with several customers serviced on the water line. The District is asking to move the meter closer to Taft to allow them to replace the line with an 18" line, and move ownership of the water meter and a portion of the water line at a point closer to Taft, approximately 3000 sq ft, to be serviced by Rincon Water Supply Corporation.

Councilman Keeney motioned, seconded by Mayor Powell, to table this item for a future meeting.

DISCUSS, CONSIDER AND ACT ON AUTHORIZING CITY STAFF TO SEEK RFP FOR ENGINEERING SERVICES FOR THE CITY OF TAFT IN DEVELOPING AN APPLICATION TO TEXAS **DEPARTMENT AGRICULTURE FOR** THE 2023-2024 **COMMUNITY OF** DEVELOPMENT PROGRAM FUND AND FOR THE DOWNTOWN REVITALIZATION PROGRAM **FOR ELIGIBLE** ACTIVITIES ASSOCIATED TO THE **TEXAS COMMUNITY** DEVELOPMENT BLOCK GRANT PROGRAM (TXCDBG) TO PERFORM REQUIRED SURVEYS, PREPARE ALL PRELIMINARY, FINAL DESIGN PLANS, AND SPECIFICATIONS, BIDDING/NEGOTIATION, PERFORM CONSTRUCTION ADMINISTRATION, AND TO CONDUCT ALL NECESSARY INTERIM AND FINAL INSPECTIONS.

Mr. Arismendez reported on the upcoming grant cycles to TDA for the 2023 CDBG application for \$500,000 funding and \$250,000 for the Downtown Revitalization Program. Councilman Rodriguez motioned, seconded by Councilman Keeney, to authorize city staff to seek RFPs for engineering services for the City of Taft in developing an application to the Texas Department of Agriculture for the 2023-2024 Community Development Program Fund and for the Downtown Revitalization Program Fund for eligible activities associated to the Texas Community Development Block Grant Program.

Mr. Arismendez reported that administrative services would be for the GLO \$3,000,000 program. Councilman Rodriguez motioned, seconded by Councilman Molina, on contracting for administrative and professional services with Langford Community Management Services to provide the full scope of application and administration services for the City of Taft GLO CDBG-MIT method of distribution projects.
