1. CALL TO ORDER AND QUORUM CHECK

There being a quorum, the meeting was called to order by Mayor Powell at 6:34 p.m.

2. INVOCATION AND PLEDGE OF ALLEGIANCE

Councilman Hernandez led the invocation and Pledge of Allegiance.

3. VISITORS

Glenn Searcy addressed the Council in regards to his concern of flares visible over the EXXON plant in Gregory and the lack of public notification. Mayor Powell suggested a scheduled meeting with representatives of the Plant to discuss. Councilman Rodriguez suggested the need for air monitors in and around the City of Taft.

No other visitors addressed the Council.

4. <u>DISCUSS, CONSIDER AND ACT TO APPROVE THE AUGUST 9, 2022, SPECIAL MEETING MINUTES AND THE REGULAR MEETING MINUTES.</u>

Mayor Powell requested a change in the motion made in Item 14. That Councilman Vara be removed as making the second, he was not present at the meeting. Councilman Hernandez motioned, seconded by Councilman Rodriguez, to approve the special and regular meeting minutes of August 9, 2022, with the noted change.

5. CONSIDER, DISCUSS AND TAKE ACTION TO AUTHORIZE THE CITY MANAGER TO RATIFY THE AGREEMENT WITH ARMSTRONG, VAUGHAN & ASSOCIATES, P.C FOR CITY'S FINANCIAL AUDIT FOR 2022-2023.

Mr. Arismendez announced that the former administrator had entered into agreement for the next year's audit, but had received concern regarding her authority to enter agreement without Council approval. This agenda item was just to ratify the agreement.

Councilman Rodriguez motioned, seconded by Councilman Hernandez, to authorize the City Manager to ratify the agreement for FY 2022-2023 Financial Audit.

6. <u>CONSIDER, DISCUSS AND ACT ON CELEBRATING HALLOWEEN ON GREEN, THE CLOSURE OF GREEN</u> AVE TO ACCOMMODATE THE EVENT AND THE CITY'S INVOLVEMENT IN SUPPORT OF THE PROGRAM

Councilman Vasquez motioned, seconded by Councilman Hernandez to hold Halloween on Green on October 29, 2022, from 6:00 pm – 9:00 pm and to close necessary streets.

CONSIDER, DISCUSS AND TAKE ACTION ON WHETHER TO APPROVE A VARIANCE REQUEST WHICH, IF APPROVED, WOULD ALLOW TH PLACEMENT OF A MANUFACTURED HOME OUTSIDE OF DESIGNATED ZONES OR A MOBILE HOME PARK AND BE PLACED AT 146 HIDALGO WITH THE LEGAL DESCRIPTION OF HIDALGO SECOND BLK 7, LOT 11, 0.118 ACRES, TAFT, TEXAS.

Mr. Arismendez informed Council that the request had been made by Debra Garcia at a public hearing before the Planning & Zoning Commission and they unanimously voted to recommend their approval of the variance to the City Council.

Councilman Hernandez motioned, seconded by Mayor Powell, to approve the variance request for the placement of a manufactured house outside of designated zones or a mobile home park and be placed at 146 Hidalgo with the legal description of Hidalgo Second, Blk 7, Lot 11, 0118 acres, Taft, Texas.

Councilman Vasquez question Mr. Saenz if he had time to fill this role in addition to his performance as Director of Public Works. Mr. Saenz advised his had 5 ½ years experience in his prior employment and that he had other duties as well.

Councilman Rodriguez motioned, seconded by Councilman Hernandez, to appoint Bernie Saenz the Chief Public Information Coordinator for the City of Taft.

Mr. Arismendez informed Council of the proposed 50' right-of-way easement along State Hwy 631, being approximately 1 mile. Raquel Ruvo, a visitor, asked representatives of Peacock Energy if the city government would be supported in any special projects, or contributions within the community, to which they replied yes. Mayor Powell commented that he believed the solar panels would be too close to the city limits, affecting the ETJ.

Councilman Rodriguez motioned, seconded by Councilman Hernandez, to approve the transmission right of way easement option, easement agreement, and grant of easement with Peacock Energy Project, LLC.

Mayor Powell reported that based on concerns from Glenn Searcy the request that this item be placed on the agenda for discussion by Councilman Hernandez, he had reached out to representatives of the Exxon Plant and asked that they approach Council with an explanation and information regarding the emissions. Councilman Rodriguez proposed that Exxon place air monitors throughout the City for monitoring by the City. Mayor Powell asked that City staff contact TCEQ and EPA regarding these emissions.

There was no action taken, item was tabled for a future meeting.
