#1. There being a quorum, the meeting was called to order at 6:31 p.m.

Mary Alice updated the council on the city financial condition. The balance of the TQIC fund was \$89,488.12 and the Street fund was \$87,025.61. The collection for city taxes was at 72.29% and the deannexed area was 54.71%.
