Discussion continued among the council. Police department gave an update in regards to the recent theft cases that have occurred during the severe winter weather. Fire department let the council know that they are in need of an air compressor for the fire trucks. They also stated that the brush truck is still in need of repairs and is asking if they can get it repaired.

Councilman Hernandez left the meeting at 11:02 a.m.

Councilman Rodriguez made a motion to that the brush truck be turned in to the mechanic and the repairs not to exceed \$15,000.00. The motion was seconded by Councilman Vasquez.
