A recording of the telephone conference will be made, and will be available to the public in accordance with the Open Meetings Act upon written request.


1. Call to order and quorum check.

4. Consider and approve the use of the Kiva Hut located at 402 Park St. to distribute food to San Patricio residents 3 times a week: Mondays, Wednesdays, Saturdays. 11 to 1 pm. in response to COVID-19 Declaration of Disaster. Said Project is sponsored by Corpus Christi Food Bank
5. Consider, discuss and take action to extend the Stay at Home Order until April 17, 2020, with an amendment to suspend penalty fees, disconnection fees, reconnection fees, processing fees, and service fees authorized under Ordinance Nos. 911, 927, and 1052.
6. Consider, discuss and take action to approve overtime pay for exempt City employees due to a Declaration of Local Distaster known as Covid-19 issued by the State and Federal government on March 13, 2020 and effective on said date pursuant to City of Taft Personnel Policy Chapter 18(J).

7. Discuss, consider and act on the operational and logistical measures related to the City's preparedness and response to the federal, state, and city's local state of emergency declarations due to a public health emergency known as Covid-19 pandemic.
8. Consider, discuss and take action to provide 30-day written notice to terminate Emergency Ambulance Services contract between City and Hidalgo Emergency Service Foundation dba South Texas Airmed.
