Should there be more than five (5) people who wish to speak on a particular issue they need to select one (1) representative to speak for them. In accordance with the Open Meetings Act, Council may not discuss or take action on any item which has not been posted on the agenda. Citizens are to refrain from any personal attacks on the council or any member of the staff. Failure to abide by these policies could result in a charge of disorderly conduct.
- 4. Consider, discuss, and take action upon the proposed tax rate for the City of Taft, take record vote, and schedule a public hearing.
- 5. Consider, discuss, and take action upon the proposed tax rate for the City of Taft Deannexed SW and take record vote.
- 6. Consider, discuss and take action to approve a resolution of the city council of the City of Taft, Texas, directing the finance director of the City of Taft to calculate the voter-approval tax rate of the City of Taft in the manner provided for a special taxing unit; determining that the meeting at which this resolution

was approved complied with the open meetings act; making other findings and provisions related to the subject; and declaring an effective date.

 The deployment or specific occasion for the implementation of security personnel or devices.
- Texas Open Meetings Act Deliberations regarding economic development negotiations. Section 551.087
