MINUTES OF REGULAR COUNCIL MEETING

On the 10th day of December, 2019, the City Council of Taft, Texas, convened in a regular session at 402 Park St, at the Kiva Hut, at 6:30 p.m. with the following members present:

#1. There being a quorum, the meeting was called to order at 6:31 p.m.

#2. Invocation & Pledge of Allegiance.

Councilman Hernandez led the Pledge of Allegiance and gave the invocation.

#3. Visitors.

Mrs. Saundra Syma, 417 Victoria, informed the council that she was upset for getting a charge for turning the water meter off.

Gilbert Ortiz, 114 Devilbiss, wants to know what the process is to turn Devilbiss from a private road to a city road.

Adam Babcock, 417 Victoria, wanted to know what the definition of tampering was

Tazh Fonville, 743 Retama, stated that he doesn't think the time to respond to a code violation letter is long enough and wants the council to revisit the ordinance.

Lisa Martinez, 518 Third St., wanted to suggest to the council to put updates on the website on what is considered brush and what is considered bulk, and stated that there is not enough room in front of her property to place the items.

#4. Consider and discuss update regarding the city's financial condition as it relates to bonded debt, past dues, recurring payments, revenues and expenditures.

Mary Alice updated the council on the financial condition. The TQIC account had \$57,364.35 and the Street account had \$130,527.78.

#5. Presentation by Noel Snedeker on the City of Taft 5 year plan.

Noel updated the council on the 5 year plan and stated that it will only work if we stay on track with the budget.

#6. Discuss, consider and take action to approve the final plat for the Mesquital Subdivision.

Matthew Longoria updated the council on the annexation process.

#13. Discussion on a resolution supporting the development and implementation of a comprehensive industrial master plan for San Patricio County, Texas. (Mayor Lopez)

Mayor explained the resolution and instructed staff to place it on the next agenda.

#14. Consider, discuss and take action to approve Ordinance No. 1050, an ordinance of the City of Taft, Texas establishing a revised rate schedule for water and wastewater services in the City of Taft, Texas.

Councilman Vara made a motion to table this item until we get more information in writing. The motion was seconded by Councilman Rodriguez.
