B. PUBLIC WORKS REPORT

Timothy Williams reported that an employee has passed for his test for a "D water license". Most of the violations the City had at the wastewater department have been satisfied. Councilman Molina inquired of Mr. Williams was familiar with the fire hydrant incident and if he was able to have any kind of communication with the crew. Mr. Williams responded he was aware and was in communication with the public works crew. Councilman Keeney stated that from the previous Public Works Directors there has been an issue of knowing where the operational valves are. Is there a way to retain a comprehensive map showing the valves and shut off areas? Mr. Williams stated, yes updated maps would assist in that matter, once the Public Works department is caught up that is something that can be worked on.

Chief John Landreth reported on items C through F. The Taft Police Department has had three felony arrests this week. Animal Control is doing well and picks up about 30 animals a month. Georgina Silvas reported for the month of January that 305 as a grand total of circulations, this includes video and audio books. Ms. Silvas is hoping that when the new library is built more people will go in and spend some time at the library. Other services offered at the library are notarizations, copies of documents and lending a listening ear to the residents that need someone to talk to.

H. Financial Report

LeeAnn Goben reported the expenses and revenues for the month of January. Ms. Goben also informed the Council Donald Allman will be coming around the second week of March to work with her in completing the audit. Mayor Vasquez expressed that he does understand that the new employees are now having to play catch up from the problems that were incurred in the past. The departments are working hard to get on track. Ms. Goben informed the council once the audit is complete there will be a better financial idea. The deadline for the completion of the audit is set for March 31st, 2024.

Councilman Molina stated that it does take some time for the hiring process and feels that it is time to place an ad so that the city is able to start receiving applicants for the position. Mayor Vasquez stated it was previously agreed that the ad and position would be placed on hold until after the completion of the audit. The work the current city manager is doing seems to be working and he's concerned that issues that have happened in the past, such as completing projects and securing grants would be missed or lost due to change in city managers. Councilman Molina stated that he believes the city needs a full time City Manager. Councilman Keeney stated if we do not advertise we will not have options. Mayor Vasquez informed the Council that he would like to see her finish what she has started. LeeAnn Goben stated that as someone who was here while the previous City Manager Mr. Linn was employed, nothing was done. Mr. Linn was hired as a full time to be working at the City Monday – Friday and he did not show up for work, we were lucky if he was here two days a week. Kandi Hubert has put together an excellent team even with the hours she works. Mayor Vasquez stated he would like to continue to wait until March 31st after the audit is complete, Councilman Garza agreed.

Zach Simmons presented on behalf of Frontier Waste and the Recycling Department. Mr. Simmons has put together a "pilot program" as a test program for the remainder of the year. The program will be a collection center to be managed by the city. The collection center should be in a gated area, the days and times will be decided by the City Administration. Each container is divided with different types of recyclable departments. Paper, plastic, cardboard and aluminum cans would be the main focus of the program. Frontier will design a QR code for the residents with more information and knowledge to help make the process easier. There will be no cost for this addition from Frontier other than utilizing man

power. Councilman Keeney stated, most of the items received are cardboard and asked if we would be able to use the bin for specific recyclable items such as cardboard? Mr. Simmons stated yes, the dividers are removable.
