7. CONSENT AGENDA

No discussion is anticipated on any of the items in this section because they are routine business, were included in the budget adoption process, or have been previously discussed as a staff report or discussion item. These items will be considered collectively by a single vote, unless a council member requests an item be removed from the consent agenda.

9. ACTION ITEMS

- 9.4.** Discuss, Consider, and possible Action to appoint an Interim City Manager for the City of Taft, Texas; establish compensation and terms of service; and authorize the Mayor to execute an interim appointment agreement.

The Presiding officer of the meeting will be present at City Council chambers, and that location will be open to the public. Other city council members may participate in this meeting by video conference, so long as their faces are visible, and their voice audible to members of the public in attendance at City Council Chambers while that member is speaking.
