Mr. Snowden addressed the City Council and spoke of ways they could structure their rates to offset their cost of service and minimize their current debt. Mr. Snowden stated he could conduct a study and return to the City Council within 60 days with his proposed rate schedules. The Cost would be \$16,000.

Mayor Vega concurred with the speaker that the City's debt was escalating. Mayor Pro-Tem Trevino asked the City Manager whether she had gone out for proposals to find Mr. Snowden. Hubert stated that, requests for proposals had not been sent out rather Mr. Snowden had come by way of the referral of the City's financial advisors. Councilman Stegall moved to direct the City Manager to advertise for proposals to conduct a rate study. Seconded by Councilman Segovia.

- 11. Council woman Hitt moved to approve Ordinance 896 raising the Taft water rates to reflect the San Patricio's Municipal Districts rates. The motion was seconded by Mayor Pro Tem Stegall. For: Unanimous. Motion carried 4-0
- Mayor Pro Tem Stegall moved to approve Resolution 537 in support of "Operation Criminal Justice Support". This program is part of "Border Star" and is required for a reimbursable account for police officers overtime. Seconded by Councilman Salcido. For: Unanimous Motion carried 4-0.
- Mayor Pro-Tem Stegall moved to postpone the cutoff date for delinquent December 2012 water bills. The fine and penalties shall still be assessed but the "cutoff date" would be postponed until January 2, 2013 at 8:00 a.m. The motion was seconded by Councilman Salcido. For: Unanimous. Motion carried 4-0.
- 14. Councilwoman Hitt moved to go on record stating the City Council as a whole will support community events i.e. a Mardi gras parade, a boll weevil festival, any activity that enhances the community's quality of life. Seconded by Councilman Salcido. For: Unanimous. Motion carried 4-0.
- **15.** Councilwoman Hitt moved to adjourn the meeting at 7:40 p.m.. The motion was seconded by Mayor Pro-Tem Stegall. For: Unanimous. Motion carried 4-0
