THE STATE OF THE CITY

The State of the City is fluid- always changing and evolving monetarily the city's finances have improved. Raising the water rates and the installation of the new badger meters has aided in the integrity of the water system. A new contract for the collection of delinquent municipal citations and EMS statements will add income to our budget and insure the departments are funded appropriately. Delinquent tax notices for both the disannexed area and Taft proper will be in the mail this week. At this time the city has collected ½ of the monies owed to satisfy the city's debt service. Bids for the renovations to the collection system and lift stations will be open on the 15th of this month and renovation of the waste water treatment plant commences on the same day – the clock is ticking.

The Police Department staffed by 10 TECLOSE officers and two civilians has reported that crime is at the all time low. There are fewer juveniles on probation and procedures have been implemented that have allowed Taft to be in control of all seized evidence. These feats were accomplished while the department stayed within budget. The City's Police Department is a fine example of community in action: toy drives, egg hunts, national night out, community affairs and being instrumental in starting the boys and girls club. The "Impaired Drivers" and "Click it or Ticket" campaigns are State Driven. Sharing, maintaining and making the firing range available to State and Federal agencies makes Taft a team player.

The Emergency Medical Services is thriving to work with the Taft Housing Authority and community regarding the vials of life. They have a community paramedic ready to respond; This agency too works for and with the community by joining the library and giving IT (Information Technology) such as computer and IPhone instructions. The staff is participating in the library foundation for the youth by reading stories to the young ones. It is an honor to report 2 of our EMS personnel were commandeered to go to West to aid in the debriefing of the victims.

The Fire Department is well staffed as of today's date, 27 volunteers, with 7 being new. To keep this community safe The Fire Department is in the process of requesting a grant from the Coastal Bend Foundation, Wilber Ellis and Pioneer for a new place of equipment – The Jaws of Life.

The Library is in the summer ready mode. Mr. Kippy will be the star of the summer reading program commencing on June 5th and every Wednesday thru June from 9am to 11am. Computer Excel classes are going to offered to the community and commence May 23rd. The city's head librarian has announced that she's shopping for new DVD's that are family friendly to beat the heat.

City Hall will be welcoming a new staff member shortly as our CFO is going north to join her family in and around the Chicago area. She will be missed by all. Interviews for the Chief Financial Officer are ongoing as well as budget time beginning. The City still has adjustments for the water bills and a quarterly newsletter is being contemplated. Elections are in November and for the record the first sign-up day is Saturday, July 27th 2013, but for city businesses it will be July 29, 2013 at City Hall. The Board of Adjustments will meet the 16th at 6:30pm for a special meeting here at the Kiva Hut. Renovation of apartments (Cottonwood) has begun and the Home Program is in full swing. The web site should be up shortly, and the residents will have full access to minutes, agendas, and coming events. All in all the State of the City is good and has a bright future.
